General Faculty *Primary* Election, Spring 2017  
**NOMINATING INSTRUCTIONS**

The Committee on Elections is conducting the Spring 2017 Primary Faculty Election in accordance with the Constitution and Bylaws of the General Faculty of the University of Arizona.

1. Nominating petitions will be available through the close of business on Friday, January 27, 2017.
2. Completed nominating petitions must be returned to the Faculty Center, 1216 E. Mabel St. (PO Box 210456), **by 5:00 P.M. Friday, January 27, 2017.**
3. Nominees are requested to submit an electronic statement, not to exceed 150 words, by email to [facultycenter@email.arizona.edu](mailto:facultycenter@email.arizona.edu) describing their reasons for seeking office. These statements will be used for publicity purposes and are provided with the announcement of the online election.
4. Only members of the General Faculty may be nominated, or nominate themselves for Faculty Senator-at-Large, Committee of Eleven, Nominating Committee, or Strategic Planning and Budget Advisory Committee (SPBAC).
5. The person being nominated must **sign** the consent form in order for the nominating petition to be valid.
6. Only signatures of members of the General (voting) Faculty are valid on nominating petitions.
7. No fewer than **twenty** valid signatures are required on petitions for Faculty Senator-at-Large, Committee of Eleven, Nominating Committee and the Strategic Planning and Budget Advisory Committee (SPBAC).
8. All members of the General Faculty are eligible for nomination to the Faculty Senate and Nominating Committee with the following exceptions:
