DECLARATION OF CANDIDACY INSTRUCTIONS

The Committee on Elections is conducting the Spring 2022 General Faculty Election in accordance with the Constitution and Bylaws of the General Faculty of the University of Arizona.

1. Declaration of Candidacy will be available online (<https://facultygovernance.arizona.edu/faculty-elections>) on Monday, January 10, 2022 at 8:00 a.m. MST.
2. Completed Declaration of Candidacy must be submitted **by 5:00 P.M. MST Friday, January 21, 2022.**
3. A candidate statement must be submitted for each seat declared. Any declarations received without an accompanying candidate statement will be disqualified.
4. Only members of the General Voting Faculty may declare candidacy for Chair of the Faculty, Vice Chair of the Faculty, Secretary of the Faculty, Faculty Senate College Representative, Committee of Eleven, Nominating Committee, or Strategic Planning and Budget Advisory Council (SPBAC). Please see the [Definition of General Faculty under Article II, Section 1 of the Constitution](#).
5. The person declaring candidacy must affirm their eligibility for the selected office and willingness to hold the office in order to be valid.
6. Electronic signatures shall be acceptable.
7. All members of the General Faculty are eligible to declare candidacy to the Faculty Senate and Nominating Committee with the following exceptions:
